Our laws for equal treatment and protections against discrimination are severely lacking in the U.S., and we need legislation to catch up with where we are culturally. The Equality Act (S.1006 in the Senate; H.R.2282 in the House) would amend the Civil Rights Act of 1964 "to include sex, sexual orientation, and gender identity among the prohibited categories of discrimination or segregation in places of public accommodation." The Senate version is with the Judiciary Committee. The House version is with five (!) different committees: Judiciary, Education and the Workforce, Financial Services, Oversight and Government Reform, and Administration. The bills already have 197 cosponsors in the House, and 47 in the Senate; it's time to move them forward out of committee (including our own Feinstein, Harris, and Panetta). (Write-up date 6/6/18)

From *Scientific American*: “[The Environmental Protection Agency (EPA)] must produce the opposing body of science Administrator Scott Pruitt has relied upon to claim that humans are not the primary drivers of global warming, a federal judge has ruled. The EPA boss has so far resisted attempts to show the science backing up his claims.... Not long after he took over as EPA administrator, Pruitt appeared on CNBC’s ‘Squawk Box,’ where he was asked about carbon dioxide and climate change. He said, ‘I would not agree that it’s a primary contributor to the global warming that we see.’ The next day, Public Employees for Environmental Responsibility,

or PEER, filed a Freedom of Information Act request seeking the studies Pruitt used to make his claims. Specifically, the group requested ‘EPA documents that support the conclusion that human activity is not the largest factor driving global climate change.’ On Friday, the chief judge of the U.S. District Court for the District of Columbia, Beryl Howell, ordered the agency to comply. ‘Particularly troubling is the apparent premise of this agency challenge to the FOIA request, namely: that the evidentiary basis for a policy or factual statement by an agency head, including about the scientific factors contributing to climate change, is inherently unknowable.’” (Write-up date 6/6/18)

The White House has announced Michael Pack as Trump's pick to head the Broadcasting Board of Governors. Pack is a close ally of Steve Bannon, and “is a sharp critic of what he calls the ‘politically correct agenda’ at universities around the country, where he says liberal media professors indoctrinate students with courses on environmental filmmaking and gay culture” (*Foreign Policy*). *Politico* reports that newly disclosed emails show that “Scott Pruitt’s EPA and the White House sought to block publication of a federal health study on a nationwide water-contamination crisis, after one Trump administration aide warned it would cause a ‘public relations nightmare.’... The intervention early this year... came as HHS’ Agency for Toxic Substances and Disease Registry was preparing to publish its assessment of a class of toxic chemicals that has contaminated water supplies near military bases, chemical plants and other sites from New York to Michigan to West Virginia. The study would show that the chemicals endanger human health at a far lower level than EPA has previously called safe, according to the emails. ‘The public, media, and Congressional reaction to these numbers is going to be huge,’ one unidentified White House aide said in an email forwarded on Jan. 30 by James Herz, a political appointee who oversees environmental issues at the OMB. The email added: ‘The impact to EPA and [the Defense Department] is going to be extremely painful. We (DoD and EPA) cannot seem to get [the Agency for Toxic Substances and Disease Registry] to realize the potential public relations nightmare this is going to be.’” The study has not yet been released. Independent researchers from several institutions, including Harvard, have concluded that more than 4,600 Puerto Ricans died in Hurricane Maria and they have reported this finding in *The New England Journal of Medicine*. Compare this to the Texas death toll following Hurricane Harvey, which is estimated at 88 persons. Despite this disparity in impact, relief efforts in Puerto Rico

The 7-2 ruling in the Masterpiece Cake Shop v. Colorado Civil Rights Commission sided—on narrow procedural grounds—with the defendant, who refused to provide a gay couple with a wedding cake citing his religious objections to gay marriage and claiming that cake making is Constitutionally protected free speech. This was a ruling on how the Colorado Civil Rights Commission handled the case at a lower level. The majority’s ruling was based on several Colorado cases in which bakers had refused to make Bible-shaped cakes bearing the message “homosexuality is a sin.” The Colorado Civil Rights Commission had upheld the bakers’ right to refuse to make these cakes. The dissenting Justices were Ruth Bader Ginsburg and Sonia Sotomayor. In their dissent, written by Bader Ginsburg, they explain that the bakers refusing to make the Bible bakers were objecting to the demeaning message that would have been put on the cakes, while the plaintiff in Masterpiece Cake Shop was not objecting to a specific message, but to the rights of an entire class of people: “Phillips [owner of Masterpiece Cake Shop] declined to make a cake he found offensive where the offensiveness of the product was determined solely by the identity of the customer requesting it.... When a couple contacts a bakery for a wedding cake, the product they are seeking is a cake celebrating their wedding—not a cake celebrating heterosexual weddings or same-sex weddings—and that is the service Craig and Mullins [the gay couple] were denied.” The dissent went on to explain that refusing to bake any same-sex wedding cakes, as Phillips did, is equivalent to having a discriminatory policy. Art Acevedo, Houston’s Police Chief, has reported that even though Houston’s immigrant population is one of the fastest-growing in the country, the city last year saw a 16 percent drop in domestic violence reports from the Hispanic community. The police blame this decline on a tough new immigration enforcement law in Texas and the increasingly hostile political climate across the country surrounding the issue of illegal immigration, which leave Latina women who are victims of domestic violence afraid to request to legal protection to which they’re entitled. Abusers know they can use potential deportation as another way of controlling those they abuse and preventing them from seeking legal recourse. Several pieces of legislation are currently before Congress that would protect the rights of children separated from their parents when the parents are arrested by Immigration and Customs Enforcement.

1. H.R. 2572, the “Protect Family Values at the Border Act,” requires that the Department of Homeland Security take into consideration safety and family concerns in any action related to the prosecution or repatriation of those apprehended for immigration violations. This legislation is currently before the House’s Judiciary and Homeland Security Committees.

2. The “HELP Separated Children Act” (S.2937 in the Senate; H.R.5950 in the House) would identify children affected by the arrest of a parent/parents on immigration charges, inform state and local services, and prioritize the release of parents so they can care for their children. S.2937 (Harris is a co-sponsor) is currently before the Senate Judiciary Committee; H.R.5950 is currently before the House Judiciary Committee.

3. The “Fair Day in Court for Kids Act” (S.2468 in the Senate; H.R. 2043 in the House) would require the government to appoint counsel to unaccompanied child refugees and other vulnerable refugees, so that they are not forced to defend themselves alone against government prosecutors. S.2468 (Feinstein and Harris are co-sponsors) is currently before the Senate Judiciary Committee. Our own Senator Kamala Harris and Lisa Murkowski have introduced the "Ending the Monopoly of Power Over Workplace Harassment through Education and Reporting Act" (EMPOWER), S.2994. Harris' web site explains that this "comprehensive, bipartisan legislation will reduce the barriers that prevent victims from speaking out and seeking justice, put companies on notice that they can no longer financially protect harassers in secret, and arm individuals with the resources they need to address systemic workplace harassment. This includes prohibiting non-disclosure and non-disparagement clauses (NDAs) that employers have required individuals to sign as a condition of receiving the job—which has perpetuated a culture of silence." The legislation creates a confidential Equal Employment Opportunity Commission hotline for reporting of on-going workplace harassment. EMPOWER requires that public companies disclose the number of settlements, judgments, and aggregate settlement amounts in connection with workplace harassment in their annual SEC filings and disclose the existence of repeat settlements with respect to a particular individual. It prohibits corporations from tax deductions for expenses and attorneys' fees in connection with litigation related to workplace harassment and treats settlement monies received by plaintiffs as non-taxable income. Finally, EMPOWER requires development of workplace training programs to clarify what actions qualify as prohibited workplace harassment. The legislation is with the Senate Finance Committee. On [June 4], eleven CAB members held a news conference and criticized Mulvaney for, among other things, canceling legally required meetings with the group. On [June 6], group members were notified that they were being replaced — and that they could not reapply for spots on the new board.... 'Firing current members of the advisory board is a huge red flag in this administration's ongoing erosion of critical consumer financial protections that help average families,' said Chi Chi Wu, an attorney for the National Consumer Law Center who has been a board member since 2016.'
