EPA: Three items.

1. **Comment on the comment period itself** for rolling back Obama-era fuel emissions. **Why this is important** - something having this much impact on consumers, industry and the environment needs a lengthy comment period. <https://www.regulations.gov/comment?D=EPA-HQ-OAR-2018-0283-0001>

“The National Highway Traffic Safety Administration (NHTSA) and the Environmental Protection Agency (EPA) are proposing to amend certain existing Corporate Average Fuel Economy (CAFE) and tailpipe carbon dioxide emissions standards for passenger cars and light trucks and establish new standards, all covering model years 2021 through 2026. More specifically, for the EPA program, EPA is proposing to amend its carbon dioxide emissions standards for model years 2021 through 2025 because they are no longer appropriate and reasonable and establishing new standards for model year 2026. The preferred alternative is to retain the model year 2020 standards for both programs through model year 2026, but comment is sought on a range of alternatives.

2. **EPA Proposed Changes to Fuel Standards** - This is the actual change. ”The Safer Affordable Fuel-Efficient Vehicles Rule for Model Years 2021-2026 Passenger Cars and Light Trucks”

“The SAFE Vehicles Rule, if finalized, would amend certain existing Corporate Average Fuel Economy (CAFE) and tailpipe carbon dioxide emissions standards for passenger cars and light trucks and establish new standards, all covering model years 2021 through 2026.”

It was controversial from Day 1, especially among for-profit colleges, who pointed to analyses arguing that the sector would be disproportionately affected.” In other words, colleges with 17% employment rate for graduates could be affected. HUD proposed rule - 30 Day Notice Minority and Women Inclusion" Information Collection for OMB Approval. Deadline Aug. 29.(think Ben Carson’s agenda) ““HUD appears to be thinking about how to create loopholes to avoid findings of disparate impact, a standard that says discrimination, regardless of intent, is illegal. It’s an important standard and the law is clear and settled. The Supreme Court affirmed the disparate impact standard in 2015. It looks like HUD wants to get around that decision and figure out how to allow discrimination in some cases. That’s a terrible and shocking idea. There’s no reason to touch the rule or introduce loopholes, confusion or uncertainty into a standard that is clear.”
